(to be determined within 24 hours after the snowstorm ends)

TIME TBA: Marcucella Hall, Crestview, DiGregorio, Campus Center upper and lower lots, Ravencroft and rear of the Library parking lots, Peterson and Rindge Hall lots, and Northfields Activity Center parking lots.

TIME TBA: Monadnock, Fieldhouse and Edgewood parking lots

TIME TBA: Northwoods, Pierce Village and Mountainview C, D and E Parking lots

TIME TBA: Mountainview A and B, Cheshire and Cheney parking lots

TIME TBA: Sawmill and Lakeview parking lots

Community members using the DiGregorio parking lot are asked to use the outer rows to allow for plowing.

Please call facilities, campus safety or residential life with specific questions.

NON-COMPLIANCE

The Campus Safety department will attempt to contact you if your vehicle was towed. If you do not have a voicemail or it is full, we do not accept responsibility for not contacting you. **IF YOUR VEHICLE IS TOWED, YOU WILL BE ASSESSED A FEE OF \$110.00 FOR THE TOW AND AN ADDITIONAL \$75 FOR HINDERING SNOW REMOVAL.** Please contact Campus Safety at 603-899-4210 to arrange the return of your vehicle. You can avoid these fees by moving your vehicle prior to the start of snow removal.

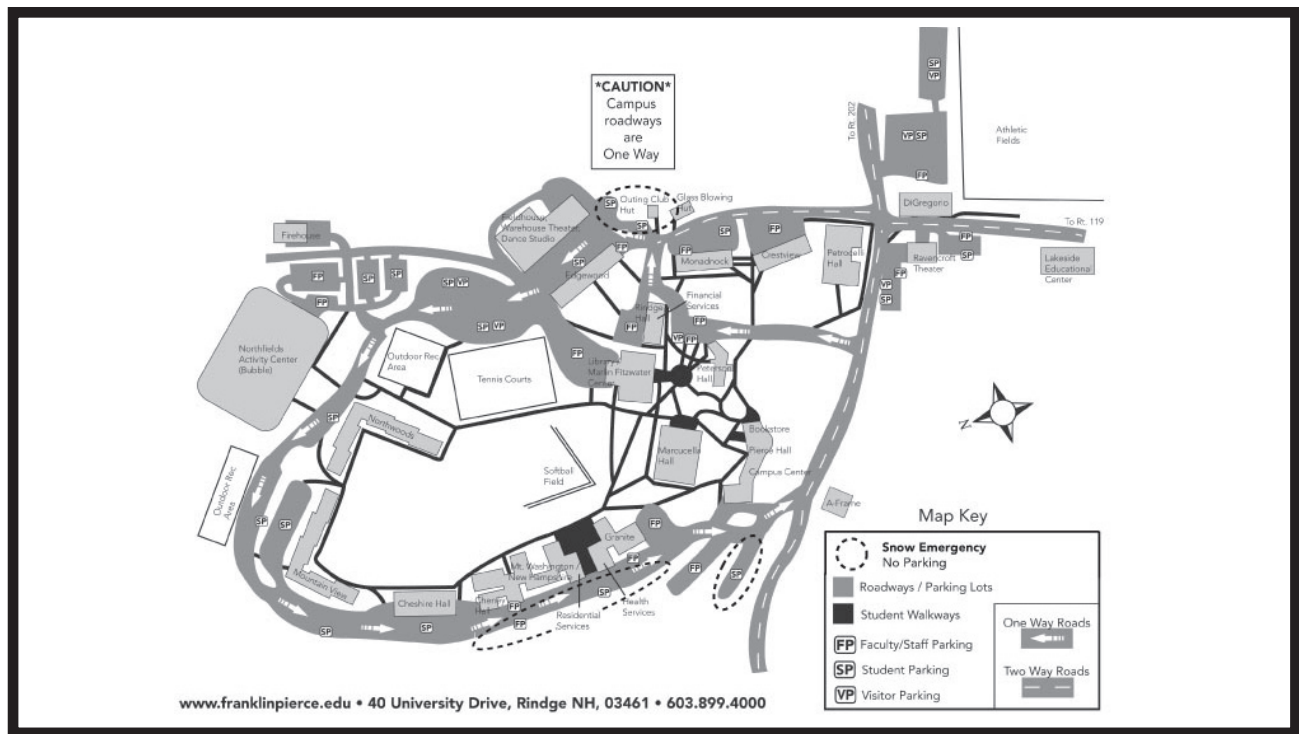

Snow Emergency

A snow emergency is declared when a snowstorm requiring snow removal is predicted for campus. When the snow emergency has been declared by the Assistant Director of Facilities, the Department of Residential Life will place notices in the residence halls and a voicemail and email will be sent. This notice does not pertain to the closing of the University or the cancellation/delay of classes. An email and voicemail will be sent declaring the end of the snow emergency once the Department of Facilities has completed snow removal operations.

Parking restrictions once a snow emergency is declared - Once the snow emergency has been declared, parking in the following areas on the campus will be restricted. All areas affected will be posted.

Cheshire Parking Lot - No parking in the center spaces of the parking lot.

Campus Center Parking Lots - Parking authorized in lined spaces only. No parallel parking in these two lots.

The Adventure Recreation Lounge - No Parking in the spaces on the side of the building. This includes the spaces by the dumpster to the corner.

Sawmill Parking Lot - No parking in the center spaces of the parking lot, please use the large lot at Lakeview until the emergency ends.

DiGregorio Lot - faculty/ staff spaces adjacent to building.

Snow Removal

Snow removal from parking lots will be determined within 24 hours of the storm ending. The specific schedule for snow removal will be determined by the Assistant Director of Facilities. A voicemail and email will be sent to advise the University community when snow removal will commence.

All vehicles will have to be moved to accommodate the removal of the snow. If your vehicle is disabled, it is your responsibility to have it working and moved so it does not impede the snow removal operation. **IF YOU DO NOT MOVE YOUR VEHICLE PRIOR TO THE START OF THE SNOW REMOVAL, YOUR VEHICLE WILL BE TOWED AT YOUR EXPENSE.** Snow shovels are available at all Lakeview, Sawmill, Monadnock, Edgewood, Northwoods, Mountainview, and Cheshire entrances. Residents living in Granite, New Hampshire and Mount Washington can borrow a shovel from the Residential Life main desk. You will need to leave your university ID to borrow a shovel.

Clearing of parking lots

For safety reasons and to help expedite the plowing of parking lots, you will not be permitted to return to the lot we are plowing until the entire lot has been completed and Campus Safety reopens the lot. Further, the flow of traffic around campus will be stopped and cars will not be permitted until the campus is completed. Please plan accordingly, **AND REMEMBER, ALWAYS YIELD TO SNOW REMOVAL EQUIPMENT!**
