

Agreement for Salary Reduction Under Section 403(b) BY THIS AGREEMENT, made between (your name) \_\_\_\_\_ and Franklin Pierce University, we agree as follows: Effective for amounts paid on or after\_\_\_\_\_\_, \_\_\_\_\_, which date is subsequent to the execution of this Agreement, my salary will be reduced by the amount indicated below. I will allocate this amount among the funding vehicles approved by Franklin Pierce University. This Agreement shall be legally binding and irrevocable for both Franklin Pierce University and myself while employment continues. However, either party may terminate or otherwise modify this Agreement as of the end of any month (or pay period, if applicable) by giving at least thirty days written notice so that this Agreement will not apply to salary subsequently paid.
